Dear Mr. Hamill:

I would like to introduce you to the **California Legacy Project** and invite you to get involved in this important effort by participating in the upcoming **Colorado and Mojave deserts "Spotlight on Conservation" Workshop**. The Legacy Project is a California Resources Agency initiative that involves a broad range of public agencies and citizen groups working together to develop information and tools that assist in making more strategic conservation investment decisions.

The Legacy Project is holding a series of nine bioregional workshops throughout the state. In recognition of the important viewpoint and knowledge you contribute to the economy, working landscapes, governance, development, conservation or recreation in the deserts, I am inviting you to join us for this workshop in Victorville on January 16 and 17, 2003. The workshop agenda is enclosed.

I recognize that a lot of time, effort and funds have already been spent in this region developing regional conservation planning efforts and collecting high quality resource data. The Legacy Project seeks to add value to existing efforts by state and federal agencies and local governments while respecting their jurisdictions, commitments and priorities. As part of the state's role in the desert, the Legacy Project is seeking to better understand the important future investments for conservation, private land stewardship programs, and rural recreation in the region. At this workshop, you will be asked to assist us in this task. You will also be asked about future partnering opportunities between the state and the federal government, local governments and the private sector in addressing both conservation and the economic health of the desert region.

You will be one of approximately 80 participants at the workshop. We are seeking participation from all parts of the Mojave and Colorado deserts (see enclosed workshop regions map) plus representation from a broad spectrum of viewpoints, including public agencies, Native American tribes, environmental groups, business and agricultural interests, academics and city planners. These workshops are not designed to reach a consensus. We want to hear the full diversity of opinions and ideas, get the best information on what is and is not working, and how you would like the state to invest any additional conservation dollars in your region.

Please return the enclosed RSVP card by January 5 to let us know whether you will attend. There is no registration or meal fee. Limited travel scholarships, underwritten by



This workshop will allow us to direct our future investments in the Colorado and Mojave deserts around important local and regional values, opportunities and concerns. 
